# Public Engagement #3

Document summarising feedback from engagement held Produced by Karakusevic Carson Architects





### Introduction

From 14 June to 9 July 2021 Karakusevic Carson Architects, Selby Trust and Haringey Council held a third round of engagement on the proposals to redevelop the Selby Centre and Bull Lane playing fields.

The engagement included a mail out consultation pack sent to 3000 households around the site with additional copies held at the Selby Centre, a website with a series of films and downloadable content, an in-person drop-in exhibition and an online drop-in meeting.

Dedicated meetings have also been held with the Selby Centre licencees, Selby Trust Board, Derbyshire School, Weir Hall Road Garden Group and

People could give their feedback via a free-post returnable questionnaire or through an online questionnaire. We have also recorded people's feedback at stakeholder meetings and the online drop-in.

In this summary, we give an overview of feedback received on the day, outcomes from the online event and data gathered from surveys. Surveys were sent in by post or filled out online on Typeform.













## **Drop-in Exhibition**

On 29 June 2021 Karakusevic Carson Architects hosted a drop-in design exhibition at the Selby Centre as part of project's third round of public engagement.

The exhibition event included presentation boards and a 3D model which showed building footprints and heights, streets and the proposed new park.

Staff members from the project team were available to ask questions to and give more information about the proposals.







# Our Emerging Plans for Selby **Urban Village**

We asked survey respondents how they felt about the inital plan for the site, including the overall layout of site including location of buildings and community facilities. This plan was developed by the design team based on feedback from engagement with the public and community stakeholders.


It looks like all age groups are covered sports facilities with various activities

# Creating a Connected and Integrated New Neighbourhood



- New residential streets with on-street parking
- New dedicated cycle routes
- New Selby Centre and sports parking accessed from Bull Lane
- O Servicing and emergency access road



# Increasing Connectivity and Responding to the Edges of the Site






# A New, Safe and Active Front to **Bull Lanes Playing Field**

We asked survey respondents to comment on emerging ideas for the Bull Lanes playing field. The initial idea explores locating the new Selby Centre on the park-front to create a new edge to Bull Lane Playing Fields. This will ensure that centre users have views across the park and also increase safety and surveillance by ensuring there is activity and lighting to deter anti-social behaviour.

CCTV throughout the public spaces.


Include a small site for Travellers.




### A Park for All

# In our proposals for the park, do you feel there is a good balance between sports and nature?

More nature please Bruce Castle park/ Pymmes & Tatem are very close by for sports and pitches. Please more nature.

There could be more focused on pre-school children. The sports looks a bit focused on older kids/adults.

All kind of different sports and well being is important

There is a lot of space reserved for sports in this park, especially considering it's right next to a sports centre already.

Seems a lot of open space with designated pitches - some smaller trails would be nice and good for walkers/kids.

There is no reasons why you can't have both

## Do you have any other comments about the information you have been presented with?

Total responses to this question: 33

All going well it looks like it could be a nice communal place to go, encouraging other communities to mix.

What provision will be made for families on low incomes?

I hope you are taking all of the comments and views into account. The main issues for me are not building the new homes adjacent to Darby Cresent, not having Selby Road used as the only access point for the homes, impact of the new homes on local residents (traffic, parking, disruption), impact of the new site on local residents (including any ASB, rubbish dumping), not building high rise buildings on the site, impact on local residents during construction and having the new site accessible to all and fully inclusive.

Will there be any section locked up after a certain time or free access all the time?

Preferences from minority groups not considered. Not a mention of tennis courts or table tennis spaces

The details of the new office and commercial building in the area is not clear

As long as there is a good childrens playground (some water and sand play would be good) with café and toilets nearby we will come. The community café at Lordship Tec is a good example of community led reasonable prices and good food.

The dwellings look very dull and Selby Centre revolting.

People like to exercise, apart from football, there are people who are hungry for other sports I think u have missed a huge opportunity NOT offering underground parking for residents. Again see Hale Village. It works a dream and frees the Village from so many vehicles. Is there also safe resident bike storage.

I would like to a have 1. water source 2. solar electric source 3. widen pathways in the Weirhall Road Community Open Space

It looks like more care has been taken to ensure the park isn't just for football players. As long as noisy children's play area are not lumped together with the only quiet areas that are sports-free and otherwise quiet then it could be a more welcoming park than the original idea.

Please do not direct more traffic down Queen St/Bull Lane. Every day there is a traffic jam.

Please make children's safety a priority. The pond needs fencing

The area will be busy & I believe a lot of nuisance will be caused to the local area.

All going well it looks like it could be a nice communial place to go, encouraging other communities to mix.

## Online Drop-in Summary

We held a webinar meeting on Zoom on Monday 21 June 2021 attended by 4 members from the local community. The meeting was hosted and chaired by Karakusevic Carson Architect's Engagement Manager. The panel included the Project Manager from Haringey Council, two staff members from the Selby Trust and two members of the design team.

#### Key points/feedback by theme:

- Parking spaces
- -There was some positive feedback on the low number of parking spaces in the design. Resident urged the team to resist the pressure for more parking in the plans, stating that London has a good transport network and expressed concerns around car pollution.
- Food growing area
- -Concerns that having an open walkway through the food growing area will open this up to potential theft. It was highlighted that other allotment in the borough have a problem with theft of produce. There were suggestions to combat this such as making allotments lockable, fences, solar lights near allotments for increased vigilance and wider path widths were discussed.
- Central positioning of Selby Centre -Positive feedback was given on the central positioning of the Selby Centre.
- -The new space between Dalby Crescent and the new housing was also well received.
- Route from west to east
- -Naming of route Weir Hall walk/Greenway. A resident liked the idea of naming the route Weir Hall Walk/Greenway to support the idea that this should be a green pathway.
- -Residents appreciated the new horseshoe shape added to the walk way as a way of preventing anti-social behaviour from electric scooters and mopeds.

- Selby and High road developments conflict
- -Residents raised concerns about the impact on local residents with potential construction traffic, debris and pollution as a result of having two developments taking place.
- Additional comments and feedback
- -Residents expressed their appreciation for having their views taken on board throughout the process after seeing their feedback being represented in the design.
- -Questions were also raised about the number of affordable homes and properties that would be given to existing residents.
